GENERAL PROVISIONS

- Art.1. This Regulation is drawn up in accordance with the provisions of the following regulatory documents:
- Law no. 199/2024 on Higher Education
- Titu Maiorescu University Charter;
- Titu Maiorescu University Organizational and Operational Regulation;
- Regulation on the students' professional activity under the European credit transfer system;
- Guidelines for granting scholarships and other types of material support to students;
- The Titu Maiorescu University's student hostel organizational and operational regulation.
- TMU's fee-related internal rules.

Art.2.

- 2.1. This Regulation sets out the amount of fees, deadlines and methods of payment of tuition fees and special fees, grouped by category, as follows: tuition fees, admission fees, final examination fees, other special fees related to admission, withdrawal from study programmes, mobility, re-enrolment, school results, archive, accommodation in the student hostel, for all levels, programmes and types of studies, for students who are Romanian citizens, citizens of European Union Member States, citizens of European Economic Area countries (Iceland, Liechtenstein and Norway) and of the Swiss Confederation, foreign citizens with the status of "Romanians from all over the world", foreign citizens under subsidiary protection, stateless persons, citizens of third countries (from outside the European Union), as well as the amount of teaching and research vacancies application fees.
- 2.2. The fees provided for in this Regulation may be paid as follows:
- a) in Lei, by candidates/students who are Romanian citizens, citizens of European Union Member States, citizens of countries belonging to the European Economic Area (Iceland, Liechtenstein and Norway) and of the Swiss Confederation, foreign citizens who have the status of "Romanians from all over the world", foreign citizens under subsidiary protection, stateless persons, who may pay by the following means:
 - > by cash at the University cashier's office.
 - > by POS at the University cashier's office,
 - > online via the University's Fee Portal,
 - by cash, at Banca Transilvania, using a pre-printed form,
 - by bank transfer (payment order/online transfer) to the following account R090BTRL04301202N01816XX opened with Banca Transilvania, or to the account R049RNCB0546029228350001 opened with BCR;
- b) in Euro, only by applicants/students who are third-country nationals (from outside the European Union), who can pay using the following means:
 - > online through the University's Fee Portal,
 - ➤ by bank transfer (payment order/online transfer) to the following account RO65BTRL04304202N01816XX opened with Banca Transilvania or to the account RO03RNCB0074029228350276 opened with BCR.

Art.3.

3.1. The admission fees (for the academic year 2024-2025) and other special fees related to the admission process for the academic year 2024-2025 apply to the candidates/students/candidates admitted in the first year of studies (bachelor's degree, master's degree, PhD programmes, residency, postgraduate courses) for the academic year 2024-2025, fee-paying residents, postgraduate students,

trainees and students who, during the academic year 2024-2025, continue/resume their studies (years II-VI).

- 3.2. The graduation/certification examination fees apply to graduates completing their degree programme in the academic year 2024-2025 and to graduates who have previously completed a degree programme and who apply for the graduation/certification examination in the academic year 2024-2025.
- 3.3. As an exception to the provisions of Article 3.1., the mobility fees/withdrawal fees for enrolment to other educational institutions, as set out in Chapter VIII, paragraph 8.3.5. apply to students who, during the academic year 2024-2025, apply for withdrawal for enrolment to other educational institutions, i.e. mobility application.
- 3.4 Study fees related to the Medicine, Medicine in English, Dental Medicine, Dental Medicine in English and Pharmacy study programmes programmes jointly comprising the bachelor's degree (1st cycle) and master's degree (2nd cycle) and that are regulated at the sectoral level can be found in this regulation in the chapters/headings labelled "BACHELOR".

Art.4.

- 4.1. Tuition fees shall be paid by students either in full or by instalments, with the exception of students who are foreign nationals of third countries, who are required to pay the full tuition fee at the beginning of the academic year, as provided for in Art. 45 para. (3) letter a) point ii) of GEO no. 194/2002 on the regime of foreigners in Romania, republished.
- 4.2. if the tuition fee is paid by instalments, payment shall be made by the deadlines established for each category, and for payments made by bank transfer, the payer must ensure that the amount has been credited to the University's account no later than the due date; otherwise, penalties will be charged, according to art. 5 of this Regulation.
- Art.5. Tuition fees/instalments not paid in full by the due date shall generate an outstanding debt, for which late payment penalties shall be calculated for each calendar day of delay, with payment of the debts being made correlatively (debt and related penalty), according to their age. The amount of the penalties for late payment shall be as follows:
- 0.3% per calendar day of delay of the outstanding tuition fee for all university study programmes, except for study programmes in the field of Health, organised by the Faculties of Medicine, Dental Medicine, Pharmacy and Nursing Tg. Jiu;
- 0,1% per calendar day of delay of the outstanding tuition fee for the study programs organized by the faculties of Medicine, Dental Medicine, Pharmacy and Nursing of Tg. Jiu. Art.6.
- 6.1. Late payment penalties shall be calculated until 30 September 2025, the penalty percentage being applied for each calendar day of delay to the amounts not paid on the due dates; the total amount of payment, thus calculated, may not exceed twice the amount of the tuition fee for the concerned academic year.
- 6.2. In the winter examination session, only students who have paid the tuition fee instalments due for the current academic year can sit the exams, and in the summer examination session only students who have paid the full tuition fee for the current academic year (including instalment IV), master students who have paid the full tuition fee for the current academic year (including instalment III) can sit the exams.

Art.7.

7.1. Discounts on the annual tuition fee may be granted, upon request, to students who meet the criteria and the procedure for granting them, set out in the Guidelines for granting scholarships and other types of material support to students.

- 7.2. Deferrals/staggered payment of tuition fees may be granted upon request, with or without the charging of penalties, with the approval of the Dean of the Faculty and the approval of the Board of Directors.
- Art.8. The special fees referred to in **Chapter VIII**, **points 5 and 7**, shall be charged only on the basis of a document issued by the Faculty Secretary's Office/Study Documents Office, either in written or electronic format (under the signature of the Chief Secretary, as appropriate). Art.9.
- 9.1. The fees provided for in Chapters I, II and IV (relating to tuition fees for Romanian citizens, EU citizens, foreign citizens who have the status of "Romanians from all over the world", foreign citizens under subsidiary protection, stateless persons, British citizens and their family members, as beneficiaries of the Agreement on the withdrawal of the United Kingdom of Great Britain and Northern Ireland from the European Union and from the European Atomic Energy Community 2019/C 384 1/01) are denominated in Euro; their payment shall be made in lei, according to the BNR exchange rate valid on the day of the payment, in the manner listed in Art. 2, point 2.2, letter a).
- 9.2. The fees provided for in Chapters **I, II and IV** apply to students who are Romanian citizens, citizens of the Member States of the European Union, citizens of countries belonging to the European Economic Area (Iceland, Liechtenstein and Norway) and of the Swiss Confederation, foreign citizens who have the status of "Romanians from all over the world", foreign citizens under subsidiary protection, stateless persons, British citizens and their family members, as beneficiaries of the Agreement on the withdrawal of the United Kingdom of Great Britain and Northern Ireland from the European Union and from the European Atomic Energy Community 2019/C 384 I/01. By exception, students who are citizens of the Member States of the European Union, citizens of countries belonging to the European Economic Area (Iceland, Liechtenstein and Norway) and of the Swiss Confederation, British citizens and their family members, as beneficiaries of the Agreement on the withdrawal of the United Kingdom of Great Britain and Northern Ireland from the European Union and from the European Atomic Energy Community 2019/C 384 I/01, may also pay these fees in euro, only by bank transfer to account RO65BTRL04304202N01816XX opened with Banca Transilvania or to account RO03RNCB0074029228350276 opened with BCR.
- 9.3. The fees provided for in Chapters VI and VII (relating to tuition fees for third-country nationals) are set in Euro, payable in Euro, in the manner provided for in Article 2, point 2.2. b) and apply only to third-country nationals (non-EU) students.
- 9.4. The fees provided for in Chapters III and V (relating to postgraduate programmes and DSPP) are in Euro, apply to all students, regardless of nationality and are payable in lei or Euro, depending on the student's citizenship, as provided above for each category.
- 9.5. The special fees, provided for in Chapter VIII, are denominated in lei and are payable in lei.
- 9.6. The fees provided for in Chapters VIII and X apply equally to all students, irrespective of citizenship. The payment method for Chapter X fees shall be governed by the student social services contract and the student hostel organizational and operational regulation.
- 9.7. The fees provided for in Chapter IX are denominated in lei and are payable in lei.
- 9.8. The first tuition fee for students coming by permanent mobility, between semesters, is half of the tuition fee for their current year of study. The tuition fees for the following academic years are as set out in this Regulation.

The amount of the fee for taking the final examinations by the graduates of other universities at TMU is established by Senate Decision, based on the contract concluded with the university where the graduates come from.
- 23.3. The fee for the graduation/certification examination **is not refundable** in case of non-attendance or failure to pass the examination.
- 23.4. By **exception**, in situations such as accidents, medical issues, death, etc., 50% of the fee will be refunded, based on a request, accompanied by supporting documents and approved by the Board of Directors; also, if the candidate gives notice in writing, at least 24 hours before taking the graduation/certification exam, of his/her withdrawal, the fee paid may be carried over to the next session, based on the candidate's written request.
- 23.5. The TMU graduates who apply individually to take the graduation examination at another university will be charged a fee for the preparation of the application file, as set out in point 8.6.3.
- 23.6. Graduates of other universities who apply individually to take the graduation examination at the TMU are charged the same fee as their own graduates.

23.7. For the submission of the habilitation thesis within the doctoral schools of IOSUD - TMU, the fee provided for in point 8.6.4 will be charged.

23.8. For the verification of similarities in the content of the bachelor's/doctoral thesis by means of the TMU anti-plagiarism software, an additional fee is charged in addition to the graduation examination fee, only if the verification is done in advance at the request of the graduate or if, after the first verification, a high percentage of similarity is found, the thesis is redone and the percentage of similarity is rechecked. The amount of the fee for the anti-plagiarism check of the thesis for the graduation examination upon the graduate's preliminary request or for the first and subsequent checks is set out in point 8.6.5.

- 25.2 The application fee for the teaching and research vacancies examination is not refundable under any circumstances.
- 25.3 By exception, if a candidate withdraws his/her application before it has been submitted to the scientific commission, the application fee may be refunded upon request.

Art.26.

- 26.1. The "STUDENT HOSTEL ACCOMMODATION FEES" chapter lists the monthly fees, denominated in Euro, representing the rent for a place of accommodation in the University's hostels, depending on the building, the surface area and the structure of the apartment, i.e. studios and apartments with 2 or 3 rooms, the amount of the deposit and the fee for the accommodation booking, on request, for the summer holiday period.
- 26.2. The accommodation procedure, the organization and operation of the hostel, the rights and duties of the persons accommodated are regulated by the Regulation on the organization and operation of the Titu Maiorescu University student hostel and by the student services/rental contract concluded between the University and the person accommodated in the hostel.
