**ABSTRACT WRITING RULES**

Abstracts should be prepared in **Times New Roman 12-point 1,5 line spacing** and word file in average page sizes. **Font Size: 12 points in the title, 12 in the text, 12 in the abstracts and 10 in the footnotes. In Abstracts: First 6nk – then 6nk. The number of words** should be a maximum of **250 words**. The author's name should be included between the title and abstract. **The author's academic title, institution, mail, and ORCID ID should be in a footnote. Keywords at the end of the abstract and the author's phone information after the JEL code should be included.**

Indeed, the subject should be briefly explained, including methodology, findings, and conclusions. The purpose of the work should be explained in at least 2-to 3 sentences.

The abstract review will be controlled by the Grammarly Program and will be passed through the blind scientific board member's process. If there is a similar subject study with the Grammarly Program, the writings will be left out of evaluation and the referee will be rejected without starting the process.

**FULL PAPER WRITING RULES**

Full texts should be submitted in the word document and written in Times New Roman 12pt, single-spaced, justified on the page with all average page margins. The APA-date method should be used for citing.

Authors name-surname(s), universities/firms, departments, and email addresses should be indicated on top of the paper after the topic of the paper. The paper should include JEL codes and keywords.

Full texts should have a minimum of 5 pages and maximum 20 pages and a minimum of 15 sources.

It should have a maximum of 5 keywords.

Full texts should include an abstract, keywords, introduction, literature review, methodology, findings, conclusion, and discussion. The list of references should be given at the end of the manuscript, after the conclusion and discussion part.

Authors are expected to make 10 minutes-presentation at the Conference.

The conference abstract and a full-paper book will be published as an e-book.

All full texts will be checked by iThenticate software and blind reviewed by Conference Scientific Board Members. The deadline for full text is 25 April 2025.

**ACCEPTANCE CRITERIA OF PROCEEDINGS**

Index criteria are applied in the paper acceptance process (similarity-authenticate-blind peer review 2 science board member process).

The acceptance/rejection of the article is informed within 20 days. The accepted list is added to our web page on the date mentioned.

Scientific review is done by the Preliminary Check and then with two peer reviews by scientific board members.

Preliminary Check: It can last 2-4 days. For the preliminary examination of journals and abstracts-full textbooks, similarity control, congress subject coverage, and formal control are done. The Congress abstract book is accepted at 5%, and the congress full-text book is lower than 20%.

Scientific Review Process: It takes 10-15 days. For the acceptance of the paper, it is enough of at least one member of the scientific committee to report positive results.

Similarity and referee reports are shared with the authors and archived for index applicants.

The Proceeding Books are indexed in the EBSCO and ProQuest eBook databases. The Proceeding Books will be applied to the WOS Proceeding Book Index.
