



List of countries for which is requested Hague apostille or Authorization

- Copies of study documents issued by the authorities of the member states of the European Union, the EEA and the Swiss Confederation (with the exception of Greece, Italy, Spain, Portugal and Cyprus) must be legalised by the competent authorities of the issuing countries. It is not mandatory to have the Hague Apostille.
- Study documents issued in Greece, Italy, Spain, Portugal and Cyprus must be stamped with the Hague Apostille.
- The legalisation of study documents with the Huge Apostille is done as follows: the ORIGINAL document (high school diploma or high school graduation certificate) is apostilled and a translation is legalised/apostilled according to the already apostilled original. If the study documents are drawn up in languages other than Romanian, English or French, their translations must be notarized before putting the Hague apostille.
- **Hague apostille:** *Diplomas from countries that are members of the Hague Convention request a Hague Apostille from the authorities of the country that issued the document.*

- **Authorization:** *For states that are not parties to the Hague Apostille Convention, diplomas must be authorised. There are two ways to do the authentication of the diploma:*
 1. *by the Ministry of Foreign Affairs of the issuing country, the Romanian Embassy / Consular Office in that country and the Romanian Ministry of Foreign Affairs*

or

 2. *by the Ministry of Foreign Affairs of the issuing country and its Embassy / Consular Office in Romania and the Romanian Ministry of Foreign Affairs.*

For countries where there are no diplomatic missions of Romania or that do not have diplomatic missions in Romania, the study documents will be authenticated with the stamp from the Ministry of Education and the Ministry of Foreign Affairs of the issuing country.
- For countries where there are no diplomatic missions of Romania or which do not have diplomatic missions in Romania, the study documents will have the visa of the Ministry of Education and the Ministry of Foreign Affairs of the issuing country.
- Exemption from authorization is allowed under the law, an international treaty to which Romania is a party or on the basis of reciprocity.
